Cybersecurity Has Never Been More Important Than Now

29% of law firms have reported a security breach.¹

36% of law firms in an American Bar Association report say they've had malware infections in their systems.¹

In a BlueVoyant Cybersecurity Firm report, nearly **15%** of a sample of global law firms show compromised networks and 100% had been targeted by cyber threats.²

In 2021, the average cost of a data breach reached **\$4.24 million** per incident, the highest in 17 years.³

Total number of security breaches increased by **17%** in 2021.⁴

Distributed denial-of-service (DDoS) attacks will grow to **15.4 million** by 2023, nearly double the 7.9 million in 2018.⁵
