RemoteDepo Pro includes ViewScript, a live speech-to-text feed of participant audio powered by Automated Speech Recognition (ASR) technology. ViewScript captures high-fidelity audio from each participant on individual channels, quickly translating it from speech into summary text for immediate review.

- View speaker identifications and timestamps
- Bookmark segments of testimony and make notes for future reference
- Search for keywords or phrases
- Post-proceeding, instantly download a PDF copy of the ViewScript feed*

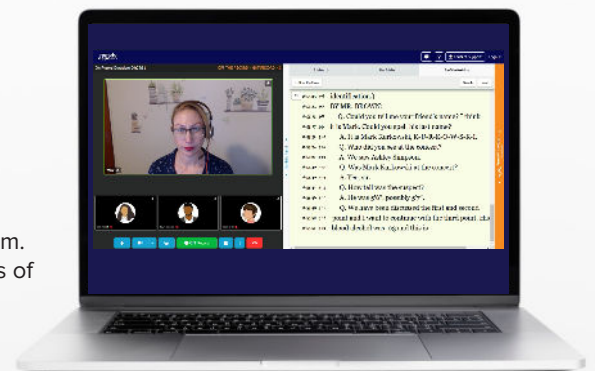
Immediate access to case assets post proceeding

RemoteDepo Pro gives you the option to view a built-in Realtime feed, allowing the stenographic Court Reporter to present the draft transcript within the platform. View and search the Realtime transcript during the proceeding and flag portions of testimony for follow up.
